Team Recruitment Program 2020/21

Youth team Coaches, Managers, adult team Captains and Members who recruit & help new teams register & pay to play in the winter 2020/21 or summer 2021 seasons of league play will receive refunds to their teams of 25% of their correlated season team fees.

Specifics:

- 1. Youth team Coaches, Assistant Coaches, Managers, adult team Captains and Members (basically adults not youth) who participated in the 2019/20 winter season or the 2020 summer season of the North Alabama FUTSAL League are eligible to take advantage of the Team Recruitment Program 2020/21 before and during the 2020/21 winter and 2021 summer seasons. Captains and Coaches/Managers of teams who participated in the 2019/20 winter season and 2020 summer season are: Ethan Belcher, Allen Craven, Scott Coon, Michael Curtis, Rashad Cylar, Wesley Dixon, Michael Hart, Peter Karacsony, Jonathan Meyers, Ken Morrison, Jose Valentin and James Young. All adult team member names are not listed here but are in the 2021 USFF registration database.
- Eligibility is limited to youth team coaches, youth team assistant coaches, youth team managers, adult team captains, and members of adult teams of returning teams who were coaches, assistant coaches, managers, captains or members of teams during the 2019/20 winter season or 2020 summer season of North Alabama FUTSAL and will be referred to as "Eligible Recruiters".
- 3. The program allows Eligible Recruiters to receive refunds of 25% of their team fees, if they recruit/help new teams join the league and play in the 2020/21 winter season or the 2021 summer season. A 25% refund of a team fee will be referred to as "Recruitment Rebate".
- 4. Recruit/help may include speaking with other teams about playing futsal, explaining to them how to register to play futsal, answering questions from them and helping them register their teams and players, possibly "hands on", in the North Alabama *FUTSAL* League as defined in Team_Registration_for_Seasons_Details.pdf under More / Documents / Registration on www.nafutsal.com by the published registration deadlines.
- 5. To qualify for Recruitment Rebates, Eligible Recruiters must perform at least one of the following actions:
 - a. Complete and submit detailed list of players on the new team. A spreadsheet template is posted under More / Documents / Registration on www.nafutsal.com for this purpose.
 - b. Sign up the team on www.nafutsal.com and ensure payment of team fees.
- 6. Only the team of the Eligible Recruiter will receive a Recruitment Rebate under this recruitment program. The newly recruited team will pay one of the normal prices, either full price, full price plus late fee or the Early Bird Special price and receive no Recruitment Rebate in all cases.
- 7. Eligible Recruiters may become eligible for multiple Recruitment Rebates if they recruit multiple teams and they join. Refunds will be calculated in sequence, i.e., 25% followed by 25% of resultant lower team fee followed by 25% of next resultant lower team fee, etc.

- 8. Recruitment Rebates may be combined with other discounts but will be applied in sequence. If an Early Bird Special discount has been given previously, it will be followed by the Recruitment Rebate, i.e., an Early Bird Special discount will be applied followed by the Recruitment Rebate.
- 9. Recruitment Rebates will be effected following Eligible Recruiters' team registrations not at the same time as their registrations, i.e. they are rebates.
